ORDER

Statement of the Case

This matter came before the Office of Campaign Finance (“OCF”) Office of the General Counsel following a determination by its Public Information and Records Management Division that: **China Dickerson, Treasurer** of the Ward 2 Democrats, Inc. (“committee”), failed to timely file the October 10th Report of Receipts and Expenditures that was due on October 10, 2024, in violation of the Campaign Finance Act of 2011, District of Columbia Official Code § 1-1163.09 et. seq. and the District of Columbia Municipal Regulations, 3 DCMR § 3017.2 et. seq.

By Notice of Hearing, Statement of Violations and Order of Appearance dated January 15, 2025, the Office of the General Counsel (“OGC”) ordered China Dickerson, (“Respondent”) to appear at a scheduled virtual hearing on January 29, 2025 and show cause why the Respondent should not be found in violation of the D.C. Official Code § 1-1163.09 et. seq. and 3 DCMR § 3017.2 et. seq. and fined accordingly.

Summary of Evidence

On January 29, 2025, the Respondent appeared pro se to answer the alleged filing violation. Laura McQueen, Legal Instruments Examiner, appeared on behalf of the Office of Campaign Finance (“OCF”). Ms. McQueen testified that the Respondent failed to timely file the October 10th Report of Receipts and Expenditures that was due on October 10, 2024, in violation of the Campaign Finance Act of 2011, District of Columbia Official Code § 1-1163.09 et. seq. and the District of Columbia Municipal Regulations, 3 DCMR § 3017.2 et. seq.

The Respondent concedes that the October 10th Report was filed late due to personal priorities and misinformation. Respondent explained that she had resigned as treasurer from the committee in preparation to take maternity leave in November 2024. The committee selected and appointed a new treasurer to replace the Respondent during her leave of absence. It was the Respondent’s understanding that the new treasurer had the necessary financial data and information needed to complete the October 10th Report filing and other future filings. The Respondent further explained that she was unaware that the October 10th Report filing had not been filed until receipt of the hearing notice from OCF. Respondent took action to correct the delinquent filing and filed the October 10th Report on January 29, 2025.

Findings of Fact

Having reviewed the allegations and the record herein, I find:

1. The Respondent is the treasurer of the Ward 2 Democrats, Inc. Political Action Committee.
2. At all times pertinent, the Respondent was required to file the October 10th Report of Receipts and Expenditures by October 10, 2024.
3. The Respondent failed to file the October 10th Report on October 10, 2024.
4. By Notice of Hearing, Statement of Violations and Order of Appearance dated January 15, 2025, the Hearing Examiner ordered the Respondent to appear at a scheduled virtual hearing on January 29, 2025, to respond to the alleged violations.
5. The Respondent appeared at the scheduled hearing on January 29, 2025, and provided a credible explanation for the delinquent filing of the October 10th Report.
6. The October 10th Report was filed on January 29, 2025, seventy-eight (78) days past due.
7. The Respondent and the committee are now compliant with the rules under the Campaign Finance Act and does not have a significant history of other delinquent report filings.

Conclusions of Law

Based on the record provided by OCF, I therefore conclude:

1. The Respondent violated D.C. Official Code § 1-1163.09(a)(1)(b) and 3 DCMR § 3017.2.
2. 3 DCMR § 3711.2(f) established a fifty-dollar (\$50) fine, per day, for failure to timely file a Report of Receipts and Expenditures.
3. 3 DCMR § 3711.1 maintains that a fine shall attach for each day of noncompliance; up to a maximum of **\$3,900.00**, pursuant to D.C. Official Code § 1-1163.35(a)(3).
4. The Director may ministerially impose fines upon the candidate, treasurer, committee, or designated agent, pursuant to 3 DCMR § 3711.1.
5. For good cause shown pursuant to 3 DCMR § 3711.8, the Director of Campaign Finance (Director) may modify, rescind, dismiss, or suspend any fine.
6. At all times pertinent, the Respondent was required to file the October 10th Report of Receipts and Expenditures on October 10, 2024, but failed to comply.

7. The Respondent appeared at the scheduled hearing and provided a credible explanation for the untimely filing of the October 10th Report.
8. The Respondent filed the October 10th Report on January 29, 2025.
9. The Respondent and the committee are now compliant with the rules under the Campaign Finance Act and does not have a significant history of other delinquent report filings.

Recommendation

In view of the foregoing and information included in the record, **I HEREBY RECOMMEND** that the Director **SUSPEND** the imposition of any fine against China Dickerson, Treasurer and Ward 2 Democrats, Inc Committee in this matter.

Notice

Any party adversely affected by an Order of the Director may: (1) file a Motion for Reconsideration (Motion) with the OCF within five (5) days after receipt of an Order, provided that, relevant evidence was omitted from consideration at the hearing (3 DCMR § 3709.13); or (2) obtain review of the Order by filing a request for a hearing *de novo* with the Board of Elections within fifteen (15) days from the date of issuance of an Order. Any fine imposed by the Director, pursuant to § 3711.2 shall become effective on the sixteenth (16th) day following the issuance of a decision or Order; provided that, the Respondent does not request a hearing *de novo* with the Board of Elections. Fines imposed shall be paid within ten (10) days of the effective date of the issued Order of the Director. Make payment by check or money order, payable to: *District of Columbia Treasurer*.
