ORDER TO ADMINISTRATIVELY DISMISS DOCKET NO. 2022 P-018

The Office of Campaign Finance, (OCF) Office of General Counsel, agreed to settle the matter, in Docket No. 2022 P-018, with Brett McMahon, Treasurer, and the Citizens for Empowerment, a Political Campaign Committee (Committee) (Respondents), for failing to timely file the 8 Day Pre-General Election, 2022, Report of Receipts and Expenditures, (8 Day Pre-General Election Report 2022), in violation of D.C. Official Code Section 1-1163.09 et seq.

On January 10, 2022, the parties entered into a Settlement and Release Agreement (January 10, 2022, Settlement Agreement) wherein, Brett McMahon, Treasurer, on behalf of the Committee and Belinda Kittles Perry, Attorney Advisor, for OCF agreed to settle the matter, for Nine Hundred and Seventy-Five Dollars (\$975), as full satisfaction and payment of a potential fine in the amount of One Thousand Nine Hundred Dollars (\$1,950) fine, in Docket No. 2022 P-018. On this same date, the Committee tendered a check to the OCF made payable to the District of Columbia Treasurer, in the amount of Nine Hundred and Seventy-Five Dollars (\$975), as payment in full, for failure to file timely the 8 Day Pre-General Election Report 2022, in Docket No. 2022 P-018.

Recommendation

Accordingly, pursuant to payment under the terms of the January 10, 2022, Settlement Agreement, in the amount Nine Hundred and Seventy-Five Dollars (\$975), the matter, in Docket No. 2022 P-018, shall be administratively dismissed.
