**ORDER TO ADMINISTRATIVELY DISMISS DOCKET NO. 2022 P-009**

The Office of Campaign Finance, (OCF) Office of General Counsel, agreed to settle the matter, in Docket No. 2022 P-009, with Cynthia Hereth , Treasurer, and the Credit Union PAC of Washington, a Political Action Committee (Committee) (Respondents), for failing to timely file the July 31st, 2022 Report of Receipts and Expenditures (July 31<sup>st</sup>, 2022 Report), in violation of D.C. Official Code Section 1-1163.09 et seq.

On February 13, 2023, the parties entered into a Settlement and Release Agreement (February 13, 2023 Settlement Agreement) wherein, Cynthia Hereth Treasurer, on behalf of the Committee and Belinda Kittles Perry, Attorney Advisor, for OCF agreed to settle the matter, for Five Hundred and Twenty-Five Dollars (\$525), as full satisfaction and payment of a potential fine in the amount of One Thousand and Fifty Dollars (\$1,050) fine, in Docket No. 2022 P-009. On June 21, 2023, the Committee tendered a check to the OCF made payable to the District of Columbia Treasurer, in the amount of Five Hundred and Twenty-Five Dollars (\$525), as payment in full, for failure to file timely the July 31<sup>st</sup>, 2022, Report in Docket No. 2022 P-009.

**Recommendation**

Accordingly, pursuant to payment under the terms of the February 13, 2023, Settlement Agreement, in the amount of Five Hundred and Twenty-Five Dollars (\$525), the matter, in Docket No. 2022 P-009, shall be administratively dismissed.
