ORDER TO ADMINISTRATIVELY DISMISS DOCKET NO. 2022 C-052

The Office of Campaign Finance, (OCF) Office of General Counsel, agreed to settle the matter in Docket No. 2022 C-052 , with Adeoye Owolewa Treasurer, and the Oye 4 US Representative 2022 (Committee) (Respondents), for failing to timely file the 8 Day Pre-General Election, 2022, Report of Receipts and Expenditures, (8 Day Pre-General Election Report 2022), in violation of D.C. Official Code Section 1-1163.09 et seq.

On February 13, 2023, the parties entered into a Settlement and Release Agreement (February 13, 2023, Settlement Agreement) wherein, Adeoye Owolewa, Treasurer, on behalf of the Committee and Belinda Kittles Perry, Attorney Advisor, for OCF agreed to settle the matter, for Six Hundred and Fifty Dollars (\$650), as full satisfaction and payment of a potential fine in the amount of One Thousand Seven Hundred Dollars (\$1,700) in Docket No.: 2022 C-052. On this same date, the Committee tendered a check to the OCF made payable to the District of Columbia Treasurer, in the amount of Six Hundred and Fifty Dollars (\$650), as payment in full, for failure to file timely the 8 Day Pre-General Election Report 2022, in Docket No. 2022 C-052 .

Recommendation

Accordingly, pursuant to payment under the terms of February 13, 2023, Settlement Agreement, in the amount of Six Hundred and Fifty Dollars (\$650), the matter , in Docket No. 2022 C-052, shall be administratively dismissed.
