
SETTLEMENT AND RELEASE AGREEMENT

This Settlement and Release Agreement ("Agreement") is entered into this 30th day of March 2022 by and between Harry Tommy Thomas Jr. ("Candidate") and the District of Columbia Office of Campaign Finance (the "OCF"). The Principal Campaign Committee Harry "Tommy" Thomas Works ("Committee") failed to timely file the Committee's March 10th Report of Receipts and Expenditures, which was due on March 10, 2022, and filed on March 17, 2022, in violation of the District of Columbia Campaign Reform Act of 2011, and a Two Hundred (\$200) Dollar fine was assessed by the OCF Office of General Council IN THE MATTER OF Harry "Tommy" Thomas Works, **Docket No: 2022 C-024**. The Committee and the OCF ("Parties") now wish to resolve all the rights, liabilities, obligations, and differences fully and finally between them.


NOW, THEREFORE, in exchange of the execution of this Agreement and in full satisfaction thereof, following the Parties' mutual execution and exchange of this Agreement, the Parties herewith agree as follows:

The Candidate, on behalf of the Committee agrees to pay OCF the sum of One Hundred (\$100) Dollars, as settlement in full satisfaction of all fines due and owing for a violation of the District of Columbia Campaign Reform Act of 2011, for failure to timely file the Committee's Report of Receipts and Expenditures due on March 10, 2022, and the OCF agrees to discharge the Two Hundred (\$200) Dollar fine assessed by the OCF Office of General Council for this violation, IN THE MATTER OF Harry "Tommy" Thomas Works, **Docket No: 2022 C-024**.
