The Office of Campaign Finance, Office of General Counsel, issued an Order on March 23, 2022, in Docket No. 2021 C-042 and that the fine imposed in the amount of Six Hundred Dollars (\$600) against Adeoye Owolewa, Treasurer and the Oye 4 Representative 2022, a Principal Campaign Committee (Committee) (Respondents), for failing to timely file the December 10, 2021, Report of Receipts and Expenditures, (December 10th, 2021, Report), in violation of D.C. Official Code Section 1-1163.09 et seq.

On April 22, 2022, the Committee tendered proceeds to the Office of Campaign Finance made payable to the District of Columbia Treasurer, in the amount of Six Hundred Dollars (\$600), for the fine owed by the Committee for failure to file timely the December 10th, 2021, Report, in Docket No. 2021 C-042.
