**ORDER**

This matter came before the Office of Campaign Finance (“OCF”), Office of General Counsel (“OGC”), pursuant to an allegation(s) by OCF’s Public Information & Records Management (“PIRM”) division that DANIEL WEDDERBUM (“Respondent”), Treasurer for DC FOR DEMOCRACY PAC failed to file the 8 DAY PRE-SPECIAL ELECTION Report of Receipts and Expenditures that was due on Monday, April 15, 2013; in accordance with the District of Columbia Official Code § 1-1163.09(B) and 1-1163.03(a)(1)(b).

In accordance with the District of Columbia Official Code §1-1163.03 (a)(1) (H), by Notice of Hearing, Statement of Violations and Order of Appearance dated April 19, 2013, OCF ordered respondent DANIEL WEDDERBUM to appear at a scheduled hearing on THURSDAY MAY 2, 2013 @ 11:00 AM and show cause why he should not be found in violation and fined accordingly. Respondent filed the required report on April 24, 2013 and is currently in compliance with the statute.

**Recommendation**

In view of the foregoing and information included in the record, I HEREBY RECOMMEND that the Director WITHDRAW the Notice of Hearing, Statement of Violations and Order of Appearance, dated April 19, 2013 and SUSPEND any fine in the matter.
