**ORDER**

This matter came before the Office of Campaign Finance (“OCF”), Office of the General Counsel (“OGC”), pursuant to an allegation(s) by OCF’s Public Information & Records Management (“PIRM”) Division that Edward Krauze, Treasurer for the Washington DC Association of Realtors political action committee failed to timely file the January 31<sup>st</sup> Reports of Receipts and Expenditures (“R&E report”), which was due on February 19, 2014, in accordance with D.C. Official Code § 1-1163.09(b) (2012) and 3 DCMR § 3017.2 (August 2013).

In accordance with D.C. Official Code §1-1163.03(a)(1)(H), by Notice of Hearing, Statement of Violations and Order of Appearance dated February 27, 2014, OCF ordered Edward Krauze (“Respondent”) to appear at a scheduled hearing on Thursday, March 13, 2014 and show cause why he should not be found in violation and fined accordingly. On March 4, 2014, OCF received an email from Susan R. Jeannotte, Vice-President and Chief Financial Officer of Greater Capital Area Association of Realtors, explaining that she emailed OCF on February 19, 2014 requesting a one day filing extension. Additionally, Ms. Jeannotte stated OCF approved the extension via email on February 19, 2014. A review of the February 19, 2014 correspondence between OCF and Ms. Jeannotte confirmed these facts. The Respondent electronically submitted the January 31<sup>st</sup> R&E report on January 20, 2014 and is currently in compliance with the statute.

**Recommendation**

In view of the foregoing and information included in the record, **I HEREBY RECOMMEND** that the Director VACATE the Notice of Hearing, Statement of Violations and Order of Appearance dated February 27, 2014.
