**ORDER**

This matter came before the Office of Campaign Finance (“OCF”), Office of the General Counsel (“OGC”), pursuant to an allegation(s) by OCF’s Reports Analysis and Audit Division (“RAAD”) that Reginald E. Black, Jr., Treasurer for the Rahlowtistry Initiative failed to respond to RAAD’s February 6, 2014 Request for Additional Information requesting submission of an Amended January 31<sup>st</sup> Report of Receipts and Expenditures, in accordance with D.C. Official Code § 1-1163.03(a)(1)(A) (2012) and 3 DCMR § 3403.2 (August 2013).

In accordance with D.C. Official Code §1-1163.03(a)(1)(H), by Notice of Hearing, Statement of Violations and Order of Appearance dated March 6, 2014, OCF ordered Reginald E. Black, Jr. (“Respondent”) to appear at a scheduled hearing on Wednesday, March 19, 2014 and show cause why he should not be found in violation and fined accordingly. OCF served this notice by regular and electronic mail. Later in the day on March 6, 2014, OCF received RAAD’s February 6, 2014 Request for Additional Information from the United States Postal Service marked as “return to sender.” On March 10, 2014, Respondent submitted an Amended January 31<sup>st</sup> Report of Receipts and Expenditures. On March 11, 2013, OCF called Respondent to verify his home address. Respondent confirmed his address and stated that because he lives in an emergency facility, sometimes his mail does not reach him; however, he does have direct access to mail he receives electronically. OCF reminded Respondent that he should regularly check his mail. Respondent is currently in compliance with the statute.

**Recommendation**

In view of the foregoing and information included in the record, **I HEREBY RECOMMEND** that the Director VACATE the Notice of Hearing, Statement of Violations and Order of Appearance dated March 6, 2014.


