ORDER

Statement of the Case

This matter came before the Office of Campaign Finance (hereinafter OCF) Office of the General Counsel following a determination by its Public Information and Records Management Division that Marc Morgan for DC (hereinafter respondent PCC), Samuel A. Moore, Treasurer, failed to timely file a June 10, 2010 Report of Receipts and Expenditures as required by D.C. Official Code §1-1102.06(a)(2001 Edition), on or before June 10, 2010.

By Notice of Hearing, Statement of Violations and Order of Appearance dated July 26, 2010, OCF ordered Samuel A. Moore (hereinafter respondent treasurer), to appear at a scheduled hearing on August 4, 2010 and show cause why the respondent PCC should not be found in violation of the D.C. Campaign Finance Reform and Conflict of Interest Act of 1974, as amended by D.C. Official Code §§1-1101.01 et seq., and fined accordingly.

Summary of Evidence

On August 4, 2010, respondent treasurer appeared at the scheduled hearing and testified that this is the first time he has served as treasurer of a committee, and that he is a novice to OCF's processes. Respondent treasurer candidly admitted having underestimated the time required to compile the committee's financial data. Further, respondent treasurer stated that he is resigning the position of treasurer, and that a new treasurer, with more experience, will accept and perform the duties of treasurer. On June 22, 2010, the respondent treasurer electronically filed the required June 10, 2010 Report of Receipts and Expenditures.

Findings of Fact

Having reviewed the allegations and the record herein, I find:

1. Respondent PCC registered with OCF on March 24, 2010.
2. Respondent PCC was required to file a June 10, 2010 Report of Receipts and Expenditures on or before June 10, 2010 in accordance with D.C. Official Code §1-1102.06(a).
3. Respondent PCC filed the required report with OCF on June 22, 2010.
4. Respondent PCC is a first-time required filer.
5. Respondent treasurer provided a credible explanation for the filing delinquency in that he is a first-time treasurer who underestimated the time required to compile the committee's financial data; notwithstanding, the required report was filed with OCF as soon as practicable.
6. Respondent PCC is currently in compliance with the statute.

Conclusions of Law

Based upon the record provided by OCF, I therefore conclude:

1. Respondent PCC violated D.C. Official Code §1-1102.06(a).
2. The penalty established at D.C. Official Code §1-1103.05(b)(3), 3DCMR §§3711.2(f), 3711.3 and 3711.4 for failure to timely file a June 10, 2010 Report of Receipts and Expenditures required by D.C. Official Code § 1-1102.06 is a fine of \$50.00 per day for each business day subsequent to the due date.
3. In accordance with D.C. Official Code §1- 1103.05(b)(3), the respondent PCC may be fined a maximum of \$350.00 for failing to timely file a June 10, 2010 Report of Receipts and Expenditures.
4. For good cause shown pursuant to 3DCMR §3711.6, the Director of the Office of Campaign Finance (Director) may modify, rescind, dismiss or suspend any fine.

5. Respondent treasurer's explanation for the filing delinquency, in that he is a first-time treasurer who underestimated the time required to compile the financial report, constitutes good cause for suspension of the fine in this matter.

Recommendation

In view of the foregoing and information included in the record, I hereby recommend that the Director suspend the imposition of a fine in this matter.
