ORDER

This matter came before the Office of Campaign Finance (hereinafter OCF) Office of the General Counsel following a determination by its Public Information and Records Management Division, that pursuant to D.C. Official Code §1-1106.02 (2001 Edition), **Felicia Buadoo-Adade** (hereinafter Respondent), Public Health Nutritionist within the Department of Health, failed to timely file a Financial Disclosure Statement for calendar year 2010 on or before May 15, 2011 as required by D.C. Official Code §1-1106.02, and also failed to file on or before the OCF sanctioned extended filing deadline of June 10, 2011.

WHEREAS by Notice of Hearing, Statement of Violations and Order of Appearance dated August 2, 2011, OCF ordered Respondent to appear at a scheduled hearing on August 16, 2011;

WHEREAS Respondent was a Public Health Nutritionist within the Department of Health;

WHEREAS Respondent was required to file a Financial Disclosure Statement with OCF for calendar year 2010, on or before June 10, 2011.

WHEREAS Respondent filed the required Financial Disclosure Statement on August 5, 2011 and submitted an affidavit explaining the untimely filing;

WHEREAS Respondent provided credible testimony for the filing delinquency in that Respondent separated from DC government in October 2010, at which time Respondent did not receive an exit interview from her agency administrator nor was Respondent informed that she had a continuing duty to file a FDS with OCF following her separation. However, upon notice by OCF, Respondent took immediate action to correct her noncompliance by filing;

WHEREAS Respondent has been a timely FDS filer since 2008 and is currently in compliance with the Statute;

IT IS ORDERED that the Notice of Hearing, Statement of Violations and Order of Appearance dated August 2, 2011 is hereby VACATED and that a fine in this matter be hereby SUSPENDED.
