Upon review of the record herein, I find that the respondent has satisfied the fine imposed in the Director's Order issued on June 8, 2015. Consequently, I further find that the respondent is in compliance with applicable regulations.

Any party adversely affected by any Order of the Director may: (1) file a Motion for Reconsideration (Motion) with OCF within five (5) days after receipt of an Order, provided that, relevant evidence was omitted from consideration at hearing (3DCMR §3709.13); or (2) obtain review of the Order by filing, a request for a **hearing de novo** with the Board of Elections, within (15) days from the date of issuance of an Order. Any fine imposed by the Director, pursuant to 3 DCMR §3711.2 shall become effective on the 16th day following the issuance of a decision and/or Order; provided that, the Respondent does not request a **hearing de novo**, pursuant to §3709.11. Fines imposed shall be paid within ten (10) days of the effective date of the issued Order of the Director. Make a payment by check or money order payable to the District of Columbia Treasurer.
