ORDER

Statement of the Case

This matter came before the Office of Campaign Finance (hereinafter OCF) Office of the General Counsel following a determination by its Public Information and Records Management Division, that pursuant to D.C. Official Code §1-1106.02 (2001 Edition), Bobby W. Austin, Vice President: University Relations, University of the District of Columbia, failed to timely file, a Financial Disclosure Statement (hereinafter FDS) for calendar year 2008, on or before May 15, 2009, as required by D.C. Official Code §1-1106.02, and also failed to file on or before the OCF sanctioned extended filing deadline of June 19, 2009.

By Notices of Hearing, Statements of Violations and Orders of Appearance dated August 13, 2009, OCF ordered Bobby W. Austin (hereinafter Respondent), to appear at a scheduled hearing on August 31, 2009, and show cause why he should not be found in violation of the D.C. Campaign Finance Reform and Conflict of Interest Act of 1974, as amended by D.C. Official Code §§1-1101.01 et seq., and fined accordingly.

Summary of Evidence

On September 15, 2009, Respondent filed an FDS for calendar year 2008, and submitted an affidavit explaining the untimely filing. In the affidavit, Respondent testified that he did not file the FDS in a timely manner because he separated from the University of the District of Columbia in January 2009. Respondent testified that after leaving the University, he began establishing retirement and work plans and forgot to file the FDS. Respondent's file shows a record of timely filing since 2003.

Findings of Fact

Having reviewed the allegations and the record herein, I find:

1. Respondent was a Vice President: University Relations, University of the District of Columbia.
2. Respondent was required to file a Financial Disclosure Statement with OCF for calendar year 2008, on or before June 19, 2009.
3. Respondent filed the required Financial Disclosure Statement on September 15, 2009.
4. Respondent has no history of FDS filing delinquencies.
5. Respondent provided a credible explanation for the filing delinquency in that after separating from the University of the District of Columbia, he became preoccupied with other matters and forgot to file; notwithstanding, upon being advised, Respondent took action to correct his noncompliance by filing.
6. Respondent is currently in compliance with the statute.

Conclusions of Law

Based upon the record provided by OCF, I therefore conclude:

1. Respondent violated D.C. Official Code §1-1106.02.
2. The penalty established at D.C. Official Code §1-1103.05(b)(3), and 3 DCMR §§3711.2(aa), 3711.2 and 3711.4 (March 2007, as amended) for failure to timely file a Financial Disclosure Statement required by D.C. Official Code §1-1106.02 is a fine of \$50.00 per day for each business day subsequent to the due date.
3. In accordance with D.C. Official Code §1-1103.05(b)(3), the respondent may be fined a maximum of \$2,000.00 for failing to timely file a Financial Disclosure Statement.

4. For good cause shown pursuant to 3 DCMR §3711.6, the Director of Campaign Finance (Director) may modify, rescind, dismiss or suspend any fine.
5. Respondent's explanation for failing to timely file is credible in that after separating from the University of the District of Columbia, he became preoccupied with other matters and forgot to file; notwithstanding, Respondent took action to correct his noncompliance; this, combined with his previous record, provides a credible basis for Respondent's failure to timely file.

Recommendation

In view of the foregoing and information included in the record, I hereby recommend that the Director suspend the imposition of the fine in this matter.
