ORDER

Statement of the Case

This matter came before the Office of Campaign Finance (hereinafter OCF) Office of the General Counsel following a determination by its Public Information and Records Management Division, that pursuant to D.C. Official Code §1-1106.02 (2001 Edition), Jon Paul Morris, Supervisory Attorney Advisor, Office of the Attorney General, failed to timely file, a Financial Disclosure Statement (hereinafter FDS) for calendar year 2008, on or before May 15, 2009, as required by D.C. Official Code §1-1106.02, and also failed to file on or before the OCF sanctioned extended filing deadline of June 19, 2009.

By Notices of Hearing, Statements of Violations and Orders of Appearance dated August 13, 2009, OCF ordered Jon Paul Morris (hereinafter Respondent), to appear at a scheduled hearing on September 8, 2009, and show cause why he should not be found in violation of the D.C. Campaign Finance Reform and Conflict of Interest Act of 1974, as amended by D.C. Official Code §§1-1101.01 et seq., and fined accordingly.

Summary of Evidence

On June 23, 2009, Respondent filed an FDS for calendar year 2008, and submitted an affidavit, on September 8, 2009, explaining the untimely filing. In the affidavit, Respondent testified that he did not file the FDS in a timely manner because he separated from the Office of the Attorney General on January 4, 2009, at which time he was not notified about the obligation to file after separation. Respondent also testified that he had moved and did not receive any notices until June 2009. Respondent's address of record was 44150 Allderwood Terrace Ashburn, VA 20147. Respondent's file shows that this was the first time he was required to file.

Findings of Fact

Having reviewed the allegations and the record herein, I find:

1. Respondent was a Supervisory Attorney Advisor, Office of the Attorney General.
2. Respondent was required to file a Financial Disclosure Statement with OCF for calendar year 2008, on or before June 19, 2009.
3. Respondent filed the required Financial Disclosure Statement on June 23, 2009.
4. Respondent has no history of FDS filing delinquencies.
5. Respondent provided a credible explanation for the filing delinquency in that after separation Respondent did not know of the continued duty to file because he was not given notice; Respondent moved and did not receive notices in the mail until June 2009; and upon being advised, Respondent took action to correct his noncompliance by filing.
6. Respondent is currently in compliance with the statute.

Conclusions of Law

Based upon the record provided by OCF, I therefore conclude:

1. Respondent violated D.C. Official Code §1-1106.02.
2. The penalty established at D.C. Official Code §1-1103.05(b)(3), and 3 DCMR §§3711.2(aa), 3711.2 and 3711.4 (March 2007, as amended) for failure to timely file a Financial Disclosure Statement required by D.C. Official Code §1-1106.02 is a fine of \$50.00 per day for each business day subsequent to the due date.
3. In accordance with D.C. Official Code §1-1103.05(b)(3), the respondent may be fined a maximum of \$2,000.00 for failing to timely file a Financial Disclosure Statement.

4. For good cause shown pursuant to 3 DCMR §3711.6, the Director of Campaign Finance (Director) may modify, rescind, dismiss or suspend any fine.
5. Respondent's explanation for failing to timely file is credible in that after separation Respondent did not know of the continued duty to file because he was not given notice; Respondent moved and did not receive notices in the mail until June 2009; and Respondent took action to correct his noncompliance provide credible bases for Respondent's failure to timely file.

Recommendation

In view of the foregoing and information included in the record, I hereby recommend that the Director suspend the imposition of the fine in this matter.
