<u>ORDER</u>

Statement of the Case

This matter came before the Office of Campaign Finance (hereinafter OCF) Office of the General Counsel following a determination by its Public Information and Records Management Division, that pursuant to D.C. Official Code §1-1106.02 (2001 Edition), Cassandra Boyd, Associate Administrator, Department of Public Works, failed to timely file, a Financial Disclosure Statement (hereinafter FDS) for calendar year 2009, on or before May 17, 2010, as required by D.C. Official Code §1-1106.02, and also failed to file on or before the OCF sanctioned extended filing deadline of June 18, 2010.

By Notice of Hearing, Statement of Violations and Order of Appearance dated August 17, 2010, OCF ordered Cassandra Boyd (hereinafter Respondent), to appear at a scheduled hearing on September 17, 2010, and show cause why she should not be found in violation of the D.C. Campaign Finance Reform and Conflict of Interest Act of 1974, as amended by D.C. Official Code §§1-1101.01 et seq., and fined accordingly.

Summary of Evidence

On August 27, 2010, Respondent filed an FDS for calendar year 2009, and submitted an affidavit explaining the untimely filing. In the affidavit, Respondent testified that she did not file in a timely manner because she did not know that she was required to file. Respondent stated that when she received the FDS in the past, she was instructed not to fill it out. This is Respondent's first year in her position. Respondent's file shows that this is the first time she was required to file.

Findings of Fact

Having reviewed the allegations and the record herein, I find:

- 1. Respondent was an Associate Administrator, Department of Public Works.
- 2. Respondent was required to file a Financial Disclosure Statement with OCF for calendar year 2009, on or before June 18, 2010.
- 3. Respondent filed the required Financial Disclosure Statement on August 27, 2010.
- 4. Respondent has no history of FDS filing delinquencies.
- 5. Respondent provided a credible explanation for the filing delinquency in that Respondent was in a new position at her Agency and did not think she had to file since she was instructed not to do so in the past; and upon being advised, Respondent took immediate action to correct her noncompliance by filing.
- 6. Respondent is currently in compliance with the statute.

Conclusions of Law

Based upon the record provided by OCF, I therefore conclude:

- 1. Respondent violated D.C. Official Code §1-1106.02.
- The penalty established at D.C. Official Code §1-1103.05(b)(3), and 3 DCMR §§3711.2(aa), 3711.2 and 3711.4 (March 2007, as amended) for failure to timely file a Financial Disclosure Statement required by D.C. Official Code §1-1106.02 is a fine of \$50.00 per day for each business day subsequent to the due date.
- 3. In accordance with D.C. Official Code §1-1103.05(b)(3), the respondent may be fined a maximum of \$2,000.00 for failing to timely file a Financial Disclosure Statement.

- 4. For good cause shown pursuant to 3 DCMR §3711.6, the Director of Campaign Finance (Director) may modify, rescind, dismiss or suspend any fine.
- 5. Respondent's explanation for failing to timely file is credible in that Respondent was in a new position at her Agency and did not think she had to file since she was instructed not to do so in the past; and Respondent took immediate action to correct her noncompliance provide credible bases for Respondent's failure to timely file.

Recommendation

In view of the foregoing and information included in the record, I hereby recommend that the Director suspend the imposition of the fine in this matter.
